

“PAY ‘Till You Go” Program Outline:

Waubeeka Family Campground understands that busy lifestyles and unstable economy add difficulty and uncertainty to securing camping reservations. We also understand the industry-wide constraints created as customers are required to pay in full when making a reservation.

Many feel compelled to hold off on securing reservations until certain they are able to attend. Sometimes, long enough that by the time they call to reserve, it’s too late and there are no vacancies.

With day-to-day life more volatile than ever and having no crystal ball, guests must consider multiple variables, prior to making commitments to a camping trip.

- *“I can’t be sure of my scheduling for next week, let alone 6 months from now.”*
- *“Do the kids have a travel game that weekend? - I don’t freaking know yet.”*
- *“Will I get my anticipated time-off when it comes time to camp? We are so shorthanded at work, I could be called in or kept late.”*
- *“Am I certain this date is “right” for me to take this vacation?”*
- *“Should I really spend the money right now?”*
- *“I don’t want to reserve if I’m unsure because cancelling may cost me money-for-nothing, or at worst case, be non-refundable.”*

Instead of the old standard of (**paying in full at time of making your reservation**), You can schedule your reservations (Including Holidays) for the 2026 season and enjoy paying as little as **ONLY 50% down** when securing your reservation with us. (you may pay more if you choose)

With this program, you decide how and when you will make your additional and final payments to your reservation balance. Balance must be paid in full 2 weeks (14 days) prior to the date of your stay. **No interest charges** will be applied to the balance you carry, with use of this program.

“Wait, what? Interest Free?????” YES!!!! With this program, you pay only a nominal service fee. - See Details in “Terms and Conditions” below (*)

AND to make the program even sweeter, Waubeeka is offering a special cancellation policy for this program! (Read on. You’re almost done!)

Cancellation Policy – “Pay ‘Till You Go” PROGRAM - ONLY:

- *Program participants may cancel their reservation at any time (up to 36 hours) prior to the date of the reservation. Any payment scheduled to occur **AFTER** the date of*

*cancellation will be VOID and will not occur. Any payment(s) made **PRIOR** to the date of cancellation will be returned as credit for the **full amount, less the \$18.50 booking fee** and can be applied toward a replacement reservation on a later date (Good for up to 12 months from date of cancellation).*

Any / All \$10.00 Monthly Service Fees paid prior to the cancellation date are non-refundable. No Monthly Service Fees shall be charged after the date of cancellation.)

Program Terms and Conditions

Participants will authorize Waubeeka to automatically charge their choice of credit or debit card for the agreed amount and on the (weekday) date selected by the participant. (There is a \$5.00 charge for declined attempts – ***We would not make multiple charge attempts. If your card is declined, We will notify you after the first declined attempt, prior to trying again.***)

(*) A \$10.00 Per month, Non-refundable Service Fee will be charged to your reservation and cannot not be offered in credit for a cancelled reservation. (***For the month(s) in-which payments are being made – ONLY.***) *You will not be charged this fee for each month between the date you make your reservation and the date of your stay with us.*

This Program cannot be used on nor combined with any other discounts, “special offers” or Discount Camping packages.

ALL reservations much be paid in full by no later than 14 days **PRIOR to** the date of your scheduled stay.
